Sealed Proposals will be received by Crafton Borough, at the Municipal Building, 100 Stotz Avenue, Pittsburgh, Pennsylvania 15205 until 10:00 A.M. on January 29, 2020 to be publicly opened and read immediately thereafter for the following project:

**JOHNSTON & N EMILY SEWER REPAIR**

This project involves rerouting and reconstructing of existing combination sewers with the following approximate quantities: 240 LF of 15" to 24" PVC pipe installation and replacement, 4 EA of manhole installation and replacement, 3 EA of lateral wye and pipe reconnections, 340 LF of 15" to 24" CIPP MH to MH Lining, abandonment and plugging of existing sewer with flowable fill, and all required bypass pumping, preconstruction documentation, site restoration, traffic control, resident notification, and as-built documentation.

Proposals shall be delivered in a sealed envelope and clearly marked on the outside with the words "JOHNSTON & N EMILY SEWER REPAIR".

**Pennsylvania Prevailing Wage rates are required to be paid on this project.**

**There will be a mandatory pre-bid meeting held at the Crafton Borough Municipal Building, 100 Stotz Avenue, on January 22, 2020 at 10:00 A.M.**

Copies of Drawings, Specifications, Instructions to Bidders, General Conditions, Forms of Proposals and Agreements are on file and open to public inspection at the office of The Gateway Engineers, Inc., 100 McMorris Road, Pittsburgh, PA 15205-9401 where sets of said documents may be obtained upon payment of fifty (\$50.00) dollars. No refund or exchange will be made for the return of any documents. A ten (\$10.00) dollar mailing fee will be charged for any documents delivered by U.S. mail.

Bids must be submitted on the forms provided by Crafton Borough. Bids to receive consideration must be accompanied by a Certified Check or Bidder's Bond from a Surety Company authorized to do business in Pennsylvania, made to the order of Crafton Borough in an amount equal to ten percent (10%) of the total amount of the Bid as a guarantee that, if the Bid is accepted, the successful Bidder will enter into an Agreement within fifteen (15) days after Notice of the Award of the Contract.

The Bids must be made to Crafton Borough, Allegheny County, Pennsylvania, and shall remain firm for a period of sixty (60) days. No Bidder may withdraw his Bid during the sixty (60) day period without forfeiting his Bid guarantee.

Performance and Labor and Material Payment Bonds, along with Public Liability and Property Damage Certificates of Insurance in the amounts specified, as well as Certificates of Workman's Compensation must be filed with the executed Agreement.

The Owner reserves the right to reject any or all Bids, or any part thereof, for any reason, and also reserves the right to waive any informality therein.
