Sealed Proposals will be received by the Borough of Crafton, at the Municipal Building, 100 Stotz Avenue, Pittsburgh, PA 15205-2893 until 11:00 A.M prevailing time on July 21, 2020 to be publicly opened and read immediately thereafter for the following projects:

CRAFTON 2020 POOL LINER

BASE AND ALTERNATE BID:

The Base Bid Work includes, includes, but is not limited to, installation of a new PVC pool liner for the main pool at the Crafton Municipal Pool including preparation, installation of a pool liner system and site restoration, complete in place. Alternate Bid Work, includes, but is not limited to, the installation of a new PVC pool liner at the Splash Pool located at the Crafton Municipal Pool including preparation, installation of a pool liner system and site restoration, complete in place.

Proposals shall be delivered in a sealed envelope and clearly marked on the outside with the words "**CRAFTON 2020 POOL LINER**".

CRAFTON BOROUGH 2020 PARK IMPROVEMENTS

BASE AND ALTERNATE BID:

Base Bid Work is to be completed at three (3) Crafton Borough Parks. Work at Crafton Park includes, but is not limited to, installation, maintenance and removal of erosion and sediment control measures; subgrade preparation and fine grading; storm sewer installation; ADA-compliant concrete sidewalks and parking stalls; new poured-in-place rubber playground surface; and site restoration, complete in place. Work at Linwood Park includes, but is not limited to, installation, maintenance and removal of erosion and sediment control measures; subgrade preparation and fine grading; new poured-in-place rubber playground surface; and site restoration, complete in place. Work at Noble Park includes, but is not limited to, chain link fence installation and site restoration, complete in place. Alternate Bid Work includes, but is not limited to, the purchase and placement of trees, benches, curb stops and line removal and striping, complete in place.

There will be a nonmandatory Pre-bid meeting on July 8, 2020 at 10:00 A.M. prevailing time at the Crafton Park Playground, located on the northside of Afton Avenue, Crafton, PA.

Proposals shall be delivered in a sealed envelope and clearly marked on the outside with the words "**CRAFTON BOROUGH 2020 PARK IMPROVEMENTS**".

Bid Documents

Special Notes for Both Bids:

Pennsylvania Prevailing Wages are required to be paid on both Contracts.

Compliance is required on both Contracts with the Pennsylvania Prevailing Wage Act of 1961, P.L. 987, No. 442; Title VI and other applicable provision of the Civil Rights Act of 1964; the Department of Labor Equal Opportunity Clause (41 CFR 60-1.4); Executive Order 11625 (Utilization of Minority Business Enterprise); Executive Order 12138 (Utilization of Female Business Enterprise); in compliance with Section 504 of Rehabilitation Act of 1973 and Americans with Disabilities Act of 1990; and the Allegheny County MBE/WBE Program enacted July 1981, which sets forth goals of thirteen (13%) percent Minority and two (2%) percent Female Business Enterprise; and the Allegheny County Ordinance #6867-12, setting forth goals of five (5%) percent Veteran Owned Small Businesses.

All Bidders shall submit the Non-Collusion Affidavit with the Proposal in order for the Proposal to be considered responsive.

Proposals to receive consideration must be accompanied by a Certified Check or Bidder's Bond from a Surety Company authorized to do business in Pennsylvania, made to the order of Crafton Borough in an amount equal to ten percent (10%) of the total amount of the Proposal as a guarantee that, if the Proposal is accepted, the successful Bidder will enter into an Agreement within fifteen (15) days after Notice of the Award of the Contract.

All proposals must be in the hands of Crafton Borough, 100 Stotz Avenue, Pittsburgh, PA 15205-2893, by 11:00 A.M. prevailing time, July 21, 2020 and the same will be opened and read publicly immediately thereafter. The Proposals must be made to Crafton Borough, Allegheny County, Pennsylvania, and shall remain firm for a period of sixty (60) days. No Bidder may withdraw his Proposal during the sixty (60) day period without forfeiting his Bid guarantee.

Performance, Maintenance, and Labor and Material Payment Bonds, along with Public Liability and Property Damage Certificates of Insurance in the amounts specified, as well as Certificates of Workman's Compensation must be filed with the executed Agreement upon acceptance of the Proposal from the successful Bidder.

The Owner reserves the right to reject any or all Bids, or any part thereof, for any reason, and also reserves the right to waive any informality therein.
