1. CALL TO ORDER

President Levasseur called to order the Regular Meeting of the Crafton Borough Council, Monday, December 28, 2020 at 7:15 PM.

2. FLAG SALUTE

The flag salute was led by Mr. Levasseur.

3. ROLL CALL

Interim Manager Sample recorded seven (7) members of Council, present as follows: Mr. Alo, Mr. Amendola, Mr. Crouse, Mr. Crown, Mr. Levasseur, Ms. Perry, and Mr. Saba. Also present was Mayor Bloom.

4. CONSENT AGENDA

Mr. Levasseur noted that the consent agenda will be moved to the first meeting of the new year.

5. CITIZEN COMMENTS

Alice Glaser, 10 Belvidere Street, inquired about the status of the new Traffic Signals. Ms. Glaser also noted that the agenda was not made available on the website.

Interim Manager Sample stated that the agenda was posted to the website for this evening and added that information and updates for the new Traffic Signals will be added to the website.

Mr. Levasseur relayed the update regarding the Traffic Signals that had been received by the Engineer earlier in the day.

6. BUSINESS AGENDA

Bond Council Healy noted that the bond ordinance needed to be re-advertise and re-adopted in order to be in line with the Borough Code and law requirements.

A) 2021 BUDGET ADOPTION

MOTION #1: it was moved and seconded (*Crown/Crouse*) to pass Crafton Borough Ordinance # 1671 authorizing the incurring of nonelectoral debt for the purpose of providing funds for certain Capital Projects and Improvements by the issuance of General Obligation Bonds, in one or more series, in the aggregate principal amount not to exceed \$9,500,000.00.

Mr. Amendola noted that the ordinance states Mr. Sample's titled as the Borough Manager, rather than the Interim Manager.

Ms. Perry agreed that the ordinance should have the proper title.

Bond Council Healy stated that he will ensure that this change is made going forward.

ROLL CALL VOTE: ALO (YES), AMENDOLA (NO), CROUSE (YES), CROWN (YES), LEVASSEUR (YES), PERRY (YES), SABA (YES).

MOTION #1 carries by a Roll Call Vote (6-1).

Mr. Levasseur wished all a Happy New Year and urged residents to contact the Borough with any urgent matters with the impending storms.
