1. CALL TO ORDER

Interim Manager Sample called to order the Reorganization Meeting of the Borough of Crafton, Monday, January 3, 2022, at 6:35 pm, in the Council Chambers of the Community Center.

Jack Kobistek, Magisterial District Justice performed the swearing in of newly elected officials via telephone, including the newly elected Borough Mayor, Coletta Perry and newly elected Council Members, Erin Bollenbacher, Colton Chandler, Kirsten Compitello, Justin Marks, Vincent Ridilla, and John Oliverio.

Mr. Kobistek congratulated all the newly elected officials.

6. NOMINATIONS AND ELECTIONS

PRESIDENT OF COUNCIL

Mayor Perry called for nominations for President of Council.

Interim Manager Sample noted that funds were budgeted for 2022 to hold Senior Diners.

Ms. Perry stated that it is still under discussion by the Recreation Board due to concerns of the COVID pandemic.

COUNCIL VACANCY

Mr. Oliverio announced that Council will be accepting Letters of Interest to fill the current vacancy created by Mayor Perry's resignation. He stated that applications and resumes will be accepted, beginning immediately, by the Interim Manager until January 17, 2022. Mr. Oliverio stated that applications will be shared and reviewed by the Borough Council. He added that Council will hold interviews at the January 27, 2022, meeting where each candidate will have five minutes to make a presentation and noted that Council may ask questions at that time. Mr. Oliverio noted that a candidate may be appointed as soon as the January 27, 2022, meeting.

Interim Manager Sample stated that the information will be made available on the Borough's website.
