 - i. Broadhead Project We are working to secure the easements needed before the project can go out to bid.

- ii. Multi Municipal Zoning Project Update The Steering Committee met on Wednesday, Nov 8th to work through edits to the calibration tables and they plan to bring the draft documents to the Planning Commission at the end of the Month.
- iii. Pool Bathhouse The construction contractors brought some issues regarding the backwall of the bathhouse to our attention last week. The contractors, architect and the engineer agreed the best option is to tear down the back wall, remove the rusted poles and rebuilt the wall from scratch. This option requires a change order in the amount \$52,700

MOTION: to ratify a change order vote that was conducted via email on November 2nd and 3rd, 2023 approving an additional \$52,700 for M.A. Dunn to deconstruct and replace the rear wall of the Bathhouse.

- iv. Public Works Building –We are working with the County to update the \$200,000 CITF grant for construction costs on the Public Works building and with Gateway and the engineering committee to develop a plan for the rest of the work on the PW building.
- v. Stairs Project The notice to proceed document has been signed and provided for the Belvidere stairs and the four other sets will be sent out to bid this week.
- vi. Trail Planning The Borough Manager has met with the DCNR rep to review the \$39.1K grant requirements. The Borough now needs to set up a steering committee for the planning process and create an RFP to select a firm to conduct the trail study.
- vii. Consent Order Agreement (COA) next steps Our Consent Order states that Crafton is required to provide preliminary plans for the final projects we needed to ensure Crafton's compliance with our consent decree. The engineering committee reviewed the full list of potential projects and will be working with the engineers in the coming months to choose the best options based on cost, volume of stormwater captured, and related opportunity costs.
