BOROUGH OF CRAFTON ORDINANCE NO.

AN ORDINANCE OF THE BOROUGH OF CRAFTON, ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING CHAPTER 214 OF THE CRAFTON BOROUGH CODE OF ORDINANCES, VEHICLES AND TRAFFIC, AS AMENDED, PROHIBITING PARKING ON THE WESTERLY SIDE OF WEST CRAFTON AVENUE BETWEEN STEUBEN STREET AND THE INTERSECTION OF WEST CRAFTON AVENUE AND CRENNELL AVENUE.

WHEREAS, Section 1202(12) of the Borough Code, 8 Pa.C.S.A. § 1202(12), authorizes the Borough of Crafton ("Borough") to regulate the streets of the Borough; and

WHEREAS, Section 1202(31) of the Borough Code, 8 Pa.C.S.A. § 1202(31), authorizes the Borough to provide for and regulate parking to promote the convenience and protection of the public; and

WHEREAS, Chapter 214 of the Crafton Borough Code of Ordinances, Vehicles and Traffic, as amended, regulates vehicles, traffic, and speed limits within the Borough; and

WHEREAS, the establishment of parking regulations serves the public interest and protects the public safety by controlling traffic; and

WHEREAS, the Borough desires to adopt the recommended changes to further control vehicles and traffic and to protect the public safety.

NOW THEREFORE, the Council of the Borough of Crafton hereby ordains and enacts as follows, incorporating the above recitals by reference:

SECTION 1. Section 214-35 of Chapter 214 of the Crafton Borough Code of Ordinances, Vehicles and Traffic, is amended as follows to insert the underlined text:

§ 214-35 Parking prohibited at all times in certain locations.

Street Side Between

West Crafton Ave Easterly Steuben Street to intersection of West Crafton Ave and Crennell Ave

SECTION 2. The appropriate Borough officials and/or designees are hereby authorized to procure and install the necessary signage to effectuate the ordinance.

SECTION 3. Should any sentence, section, clause, part or provision of this Ordinance be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of the Ordinance as a whole, other than the part declared to be invalid.

SECTION 4. All prior ordinances are hereby repealed in whole or in part to the extent inconsistent herewith.
