**BOROUGH OF CRAFTON
ORDINANCE NO. ____**

AN ORDINANCE OF THE BOROUGH OF CRAFTON, ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING CHAPTER 214 OF THE CRAFTON BOROUGH CODE OF ORDINANCES, VEHICLES AND TRAFFIC, AS AMENDED, ESTABLISHING STOP INTERSECTIONS ON CLEARVIEW AVENUE AND HARRIS AVENUE AND PROHIBITING PARKING AT ALL TIMES ON JOHNSTON STREET, CRENNELL AVENUE, AND WEST CRAFTON AVENUE.

WHEREAS, Section 1202(12) of the Borough Code, 8 Pa.C.S.A. § 1202(12), authorizes the Borough of Crafton (“Borough”) to regulate the streets of the Borough; and

WHEREAS, Section 1202(31) of the Borough Code, 8 Pa.C.S.A. § 1202(31), authorizes the Borough to provide for and regulate parking to promote the convenience and protection of the public; and

WHEREAS, Chapter 214 of the Crafton Borough Code of Ordinances, Vehicles and Traffic, as amended, regulates vehicles, traffic, and speed limits within the Borough; and

WHEREAS, the establishment of one-way streets, stop intersections, and parking regulations serves the public interest and protects the public safety by controlling traffic; and

WHEREAS, the Borough desires to adopt the recommended changes to further control vehicles and traffic and to protect the public safety.

NOW THEREFORE, the Council of the Borough of Crafton hereby ordains and enacts as follows, incorporating the above recitals by reference:

SECTION 1. Section 214-25 of Chapter 214 of the Crafton Borough Code of Ordinances, Vehicles and Traffic, is amended as follows to insert the underlined text:

§ 214-25 Stop intersections established.

Street	Stop Intersection (at)	Direction of Travel
<u>Clearview Ave</u>	<u>Harris Avenue</u>	<u>North and south</u>
<u>Harris Ave</u>	<u>Clearview Avenue</u>	<u>West</u>

SECTION 2. Section 214-35 of Chapter 214 of the Crafton Borough Code of Ordinances, Vehicles and Traffic, is amended as follows to insert the underlined text:

§ 214-35 Parking prohibited at all times in certain locations.

Street	Side	Between
<u>Johnston Street</u>	<u>Westerly</u>	<u>Crafton Blvd to Morton Street</u>
<u>West Crafton Ave</u>	<u>Easterly</u>	<u>Steuben Street to intersection of West Crafton Ave and Crennell Ave</u>
<u>Crennell Ave</u>	<u>Westerly</u>	<u>Broadhead Ave and 55 Crennell Ave</u>

SECTION 3. The appropriate Borough officials and/or designees are hereby authorized to procure and install the necessary signage to effectuate Sections 1 – 4 hereof.

SECTION 4. Should any sentence, section, clause, part or provision of this Ordinance be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of the Ordinance as a whole, other than the part declared to be invalid.

SECTION 5. All prior ordinances are hereby repealed in whole or in part to the extent inconsistent herewith.

SECTION 6. This Ordinance shall take effect in accordance with applicable law.
