

**PUBLIC NOTICE
BOROUGH OF CRAFTON**

At its regular meeting to be held on Monday, May 13, 2019 at 7:15 p.m., in Council Chambers at the Crafton Borough Building and Community Center, 100 Stotz Avenue, Crafton, PA 15205, the Council of the Borough of Crafton will consider the adoption of, and if appropriate enact, two proposed ordinances as follows:

1. The first proposed ordinance is entitled:

AN ORDINANCE OF THE BOROUGH OF CRAFTON, ALLEGHENY COUNTY, PENNSYLVANIA,
AMENDING CHAPTER 50 OF THE CRAFTON BOROUGH CODE OF ORDINANCES,
RECREATION BOARD, AS AMENDED, INCREASING THE RECREATION BOARD TO NINE
MEMBERS AND AMENDING THE DATE OF THE EXPIRATION OF TERMS.

This proposed ordinance amends Chapter 50 of the Crafton Borough Code of Ordinances, Recreation Board, as amended, to alter the number of members on the Recreation Board from seven to nine members and to alter the date of expiration of the terms of Recreation Board Members.

2. The second proposed ordinance is entitled:

AN ORDINANCE OF THE BOROUGH OF CRAFTON, ALLEGHENY COUNTY, PENNSYLVANIA,
AMENDING CHAPTER 29 OF THE CRAFTON BOROUGH CODE OF ORDINANCES, PARK AND
SHADE TREE COMMISSION, AS AMENDED, TO ESTABLISH THE SHADE TREE COMMISSION
AND THE DUTIES AND RESPONSIBILITIES THEREOF AND TO PROVIDE FOR THE
REGULATION, PROTECTION AND MAINTENANCE OF CERTAIN PLANTS, SHRUBS AND
TREES IN THE BOROUGH.

This proposed ordinance amends Chapter 29 of the Crafton Borough Code of Ordinances, Parks and Shade Tree Commission, as amended, to: (1) establish the Shade Tree Commission and the duties and responsibilities thereof; (2) provide for the regulations and protection of plants, shrubs and trees; (3) provide for entry onto property and to maintain and care for trees or plants; (4) provide for the care, removal, replanting and replacement of public trees; (5) establish procedural requirements and guidelines for maintaining shade trees; (6) regulate trees on private property; (7) provide penalties for violations; and (8) repeal all inconsistent ordinances.
