RESOLUTION 2023-013

A RESOLUTION OF THE BOROUGH OF CRAFTON, ALLEGHENY COUNTY, PENNSYLVANIA UPDATING THE BOROUGH'S GENERAL SCHEDULE OF FEES, COSTS, CHARGES, AND EXPENSES PURSUANT TO BOROUGH ORDINANCES AND REPEALING ANY AND ALL RESOLUTIONS INCONSISTANT THEREWITH.

WHEREAS, Section 1202 of the Borough Code, 53 P.S. §46202, authorizes the Council of the Borough of Crafton (the "Borough") to update Section 15 MISCELANEOUS FEES, subsection H, Military Banners of the General Schedule of Fees as is necessary to cover the costs associated with Borough services and the collection of Borough accounts and expenditures; and

WHEREAS, the Council of the Borough desires to update Section 15. MISCELANOUS FEES, Subsection H. Military Banners of the General Schedule of Fees setting new fees for the Borough's Military Banner program and to repeal any and all resolutions inconsistent herewith.

NOW, THEREFORE, the Council of the Borough of Crafton hereby resolves as follows:

SECTION I. ADOPTION: The Updated Fee Schedule is established and adopted as the updated fee schedule for the Military Banner program of the Borough of Crafton pursuant to the Crafton Borough Code of Ordinances, including but not limited to Chapter 104 of the Crafton Borough Code of Ordinances, Fees for Borough Services. All fees referenced in the said Updated Fee Schedule are non-refundable, unless otherwise stated.

SECTION 2. REPEALER: All prior fee schedules and resolutions are hereby repealed in whole or in part to the extent inconsistent herewith.

SECTION 3. EFFECTIVE DATE: This Resolution shall take effect on July 1, 2023, and in accordance with applicable law.

Section 15. MISCELANEOUS FEES

Subsection H. Military Banners

- (1) Banner on Pole/Registration: \$125 – Banner will remain in place for 4 years.**
- (2) Two-Sided Banner Registration: \$175 – Banners will remain in place for 4 years.**
- (3) Yard/Mini Banners: \$30**
- (4) Banner Replacements: \$75 – Replacement banner will remain in place for 4 years.**
- (5) Shipping & Handling: \$10**
