**RESOLUTION NO. 2020-17**

**A RESOLUTION OF THE TOWNSHIP/BOROUGH  
OF CRAFTON, ALLEGHENY COUNTY,  
PENNSYLVANIA, AUTHORIZING THE ADOPTION  
OF AN INTERGOVERNMENTAL COOPERATION  
AGREEMENT PERTAINING TO ESTABLISHMENT  
OF A UNIFORM CONSTRUCTION CODE BOARD  
OF APPEALS.**

**WHEREAS**, the Board of Commissioners/ Borough Council of the Township/Borough of CRAFTON has determined that it is in the best interest of the residents of the Township/Borough to be served by the Char West Council of Governments Appeals Board to address appeals relative to the Township's/Borough's administration of the Pennsylvania Uniform Construction Code ; and

**WHEREAS**, the Township/Borough desires to enter into an Agreement with the other Municipal Members of the Char-West COG, which permits the Township/Borough to establish and join the Char West Council of Governments Appeals Board under certain terms and conditions; and

**WHEREAS**, the Board of Commissioners/ Borough Council of the Township/Borough believes that this sharing of resources and inter-municipal cooperation will serve to foster the health, safety and welfare of its citizens and residents; and

**WHEREAS**, the Township/Borough wishes to memorialize their adoption of this Agreement by Resolution, as permitted by 53 PA.C.S.A. §2305.

NOW, THEREFORE, pursuant to the authority granted by the Constitution and the General Assembly of the Commonwealth of Pennsylvania, BE IT RESOLVED AND IT IS HEREBY RESOLVED AND ENACTED by the Township Board of Commissioners/Borough Council of the Township/Borough of CRAFTON as follows:

**Section 1. Authorization to Execute Agreement.** The Proper Officials of the Township/Borough are authorized to enter into the Intergovernmental Cooperation Agreement in the form and content of attached Exhibit "A" which is incorporated by reference herein.

**Section 2. Savings Clause.** In the event any provision of this Resolution or its Application to any person, corporation and / or other entity under any circumstances shall be held to be unconstitutional, illegal, or invalid, then the remainder of this Resolution shall not be affected thereby. In lieu of each clause or provision of this Resolution, which is deemed to be illegal, invalid or unenforceable, there shall be added, as part of this Resolution, a clause or provision as similar in terms to the unenforceable provision as may be possible and as may be

legal, valid and enforceable.

**Section 3. Repealer.** In the event any Resolution or part thereof conflicts with the provisions of this Resolution, the same shall be and is hereby repealed insofar as the same effects this Resolution.

**Section 4. Effective Date.** This Resolution shall be in force and effect upon adoption.
